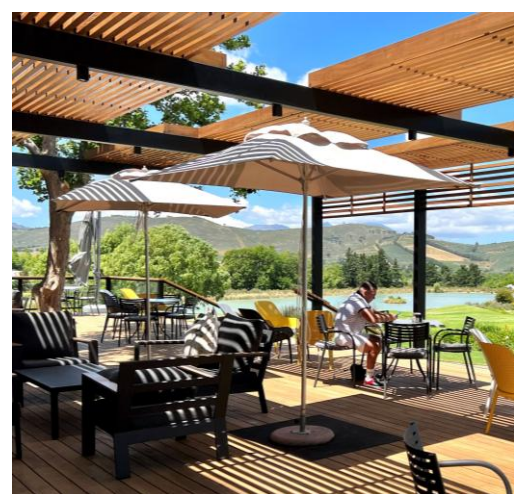

Thank you for your interest in becoming a member of the EGC. We value your interest, and we are excited to share the following information with you. In the spirit of the unity of a fine Club, members are encouraged to invite their friends and associates to join.

We offer different membership categories for golf, social and tennis.*



ENTRANCE FEE

This is a once off fee you pay when you initially join the club as a Full Golf Member or when you join as Special Social Member as a new homeowner who is not playing golf. With the payment of the entrance fee, you become a voting member in the EGC. The entrance fee can be settled as a once-off payment.

ANNUAL SUBSCRIPTIONS

Our financial year runs from 1st September to 31st August. Should you join during this period your annual subscription will be pro-rated. Notice of new fees are sent out during the month of July and are payable by the 31st of August at the latest, when the new subscription year starts. Debit order facilities are available to pay monthly if you should prefer. Please ask the membership office for a debit order form should you wish to pay monthly (a 5.5% interest rate will be applied).

SOCIAL MEMBERSHIPS AND TENNIS

We have social membership options for our non-golfing homeowners to enjoy the club offerings and facilities. All Erinvale members can apply for additional Tennis Family Membership at a small annual administration fee.

CLUBHOUSE ACCOUNT

Members have the opportunity to load funds onto their Clubhouse spending account for cashless convenience in the club. This is our preferred way of transacting within the club. Please contact our Clubhouse Receptionists to upload funds onto your spending account.

EGC SUBSCRIPTION FEES

1 SEPTEMBER 2025 – 31 AUGUST 2026

GENERAL TERMS & CONDITIONS

- The current entrance fee is R 20 000.
- The subscription fees are due on 1st September 2025. Debit order facilities are available to pay monthly if you should prefer that. Please ask the membership office for a debit order form to pay monthly (a 5.5% interest rate will be applied annually).
- Junior Members, when no longer eligible under the term of Pupil or Student may apply for Full Membership.
If accepted, the applicable entrance fee is payable at the following conditions:
 - a.) If the applicant was EGC Junior Member for less than two years: Full entrance fee
 - b.) If the applicant was EGC Junior Member for more than two up to five years: 50% entrance fee
 - c.) If the applicant was EGC Junior Member for over five years: 20% entrance fee
- Subscription fees include access to the Erinvale clubhouse facilities
- Subscription fees include all Green Fees and access to the golf course (subject to booking), all practice facilities as well as complimentary usage of driving range & range balls (**applicable only for golf memberships / not for social memberships**)
- Club member competitions are held on Tuesdays, Thursdays and Saturdays. A small competition fee is charged on members competition days.
- Members do not acquire any proprietary interest in a membership, which may not be sold or transferred. If a Member resigns, the membership will revert back to the Club free of charge. **All membership applications are subject to availability and written acceptance.**
- **Written notice to the EGC is required upon membership termination or changes.**
- The rights and obligations of all Members are governed by the terms and conditions of the EGC Constitution.
