**B. Imposition of Speeding Fines**

*This annexure provides information in terms of the Imposition of Fines as described in the Erinvale Estate Rules, Addendum 'A' – The Process.*

*By signing Schedule "A" when purchasing a property on Erinvale Estate, the Member has agreed to be subject to all the obligations of membership of the HOA in terms of its Constitution. As per Clause 3.6.6 of the Constitution, the Member shall be obliged to inform the members of their households, their guests, employees, invitees and/or tenants, in addition to the member, for any breach. The member shall be responsible and liable for the acts and omissions of their guests, employees and/or tenants and indemnifies the Association accordingly.*

**The Process**

*The member concerned will be notified in writing:*

- *Date & time;*
- *Speed captured including an image;*
- *Violation history;*
- *The warning or fine, whichever the case may be, imposed by the Association;*
- *Any additional information the Association may consider applicable.*

*In light of the serious nature of excessive speeding on the Estate, any speed captured in excess of 70 km/h will result in an immediate fine of R1,000. Any further breach by the same member/driver will incur fines up to a maximum of R2,500 per breach.*

*A member may dispute the breach and/or amount of the fine imposed and has the right to have the issue adjudicated in accordance with Clause 7.3 in the Constitution. Should a member exercise this right, written notice thereof must be given to the Estate Manager within 14 days of the date of the delivery of the breach notice. Failure to do so will be interpreted as an acceptance of the breach and fine, as may be applicable, and such fine is due and payable in accordance with regulations.*

*A Resolution was proposed in respect of the above Notice and Imposition of Speeding Fines and adopted at the Trustee Meeting of 30<sup>th</sup> April 2024.*
